Leadership Welcome

Dear Friend of Gift of Life.

We experienced a remarkable year of growth in 2018, with 163 transplants facilitated, more than three each week of the year. We held 2,410 donor recruitment drives across the United States and in Israel. That's 600 more than in 2017, and a record number for Gift of Life. With this boost to recruiting, we surpassed 300,000 active donors in the registry, adding 40,000 new donors in one year.



Our annual gala in New York City honoring Dr. Miriam and Sheldon G. Adelson raised \$9.5 million from supporters, during the elegant evening event at Cipriani.

The inaugural Los Angeles gala at the SLS Beverly Hills featured the first Steven Bochco Award given to stem cell donor Eric Gurevich. The gala honoree was Kim Kardashian West.

The high point of the year was the moment at the New York Gala when we announced plans for Gift of Life's future: in 2019 we will relocate to a new headquarters to accommodate our growing organization. Even more exciting, we will open a state-of-the-art, registry-integrated stem cell collection center in our offices. Our goal is to give donors the best possible collection experience in a comfortable and beautiful setting, continuing our tradition of being an innovator in the field.

Future plans include a Bio/Bank, where we can collect and store cells for use by transplant centers at a moment's notice.

On behalf of the Board of Directors and all the patients we serve around the world, thank you for providing the support necessary for our mission to cure blood cancer through through cellular therapies.

On World Marrow Donor Day Gift of Life held the first World Swab Tour, a day of marrow donor swab drives with registries around the world through our partnership with PSI CRO, a global clinical research organization. Our Campus Ambassadors held drives at nearly 100 universities, donors shared photos holding their "I Donated" signs, and dozens of World Merit members



participated with selfies from countries around the globe.

To raise awareness about marrow donation, WMDA issued a challenge to cele-

We are in an exciting time in cancer research and treatment. This will not only provide our donors with a warm, friendly donation experience, we will be able to engage in other innovations, for example, the establishment of a BioBank of "off the shelf" frozen cells available to patients at a moment's notice. These exciting initiatives will serve to motivate registries all over the world to follow our lead. But we can't do it without you. 





At Gift of Life's annual One Huge Night Gala in New York on October 10, Dr. Miriam and Sheldon G. Adelson, trustees of the Adelson Family Foundation, were honored with Gift of Life's highest honor, the Partners for Life Award. Presented by last year's honoree, Shari Redstone, the award recognized the Adelsons for their years of ongoing support for Gift of Life. The Adelsons then announced a \$4 million gift to the organization, to a standing ovation.

Thanks to the support of Dr. Miriam and Sheldon G. Adelson and their generous support, Gift of Life will open its stem cell collection center in 2019.



The Gift of Life Campus Ambassador Program (CAP) is our primary approach to recruiting the crucial donor demographic of 18-to-25 year olds. This group is preferred by transplant centers as young donors give recipients the best chance of a successful result. Since CAP began in 2014, the program has found 456 matches for patients that have resulted in 66 completed transplants, including 14 of our CAP interns. 


